PUBLIC COMMENTS: Roger Estlack spoke to Council about agenda item #7, related to the airport. Two months ago, the CEDC contracted with a firm named Placer AI,(a full presentation will be given in the future), that uses cell phone data to assist with marketing information. It can tell how many people attended a certain event without identifying markers. This program can gage if someone is from Clarendon, or if they had lunch at Sonic. The CEDC is going to use this technology to help businesses identify potential markets for goods that are selling or what we are leaking in terms of what people are going to other towns to purchase. This will give the local merchants the opportunity to fill the gap in what people are going out of town to purchase. Another use is to look at events and geofence off and determine how many people attended that event, where they came from, how long they stayed and where all they went while they were here. The CEDC believes this tool will help be more effective with advertising and help local merchants. He brought it up tonight because at last month's Council Meeting, there was a gentleman here talking about the airport and the possibility of having a fuel station. The gentleman made a comment that only 3-4 people use the airport each month, which Mr. Estlack felt was underestimated. Mr. Estlack looked at the Placer data for the airport and found over the last 12 months there have been 556 visits to the airport by 332 visitors. Some of those could be duplicates or city workers, but there are much more than 3-4 a month. Mr. Estlack just wanted Council to know the facility was being used.
