PUBLIC COMMENTS: Ralph Graves, spoke about agenda item #5, said that he had bought property on the JA Road by the Community Church off 8th Street. He wanted to have an unused street closed. He had asked for it to be put on the agenda many times. He brought the paperwork over and found out it had been put on the August agenda and he was never notified. The streets are landlocked, he would like to close half the alley, and it is landlocked also.

Roger Estlack also spoke about agenda item #5. He said no disrespect to Mr. Graves, but just from an economic standpoint, he stands in opposition to closing roads or alleys. He believes in the principle that the city should not give up its right of way or platted streets because we do not know what is going to happen in the future. There is nothing stopping Mr. Graves from enjoying the land he owns and someone may want to put in a housing development out there. The seven hundred block of Collinson was nothing but overgrown mesquite trees and brush with barbwire fence around it. No one ever thought it would be anything then ten years ago Peter Odima built nice apartment there. The last time this was on the agenda he spoke about Fourth Street and Collinson and how towns always seem to grow to the south and west, it is a natural thing for communities. Within months of closing the street for Mr. Gray and Mr. Black, Cameron Word built a house behind them and had to figure out how to get utilities back there. Mr. Estlack asked Council to keep their options open for the future and for future councils and for future people who might own that property
