HB 1522 Compliance- Taxpayer Impact Statement

Under the proposed budget and tax rate for FY 202-2026, the average homeowner (based on the City's 2025 Average homestead taxable value) would pay:

- \$118.22 more than in the current year
- \$26.03 more than under the no-new-revenue rate.

This notice informs taxpayers of the potential impact of the proposed budget and tax rate for Fiscal Year 2025-2026, comparing what would be paid under the no-new-revenue tax rate versus the proposed tax rate.

Prior Year Tax Bill= 0.593711 x 89,404/100= 530.80 No-New-Revenue (NNR) Tax Bill= 0.537774 x 115,847/100=622.99 Proposed Tax Bill= 0.560241 x 115,847/100= 649.02

Summary

If the City of Clarendon adopts the proposed tax rate of \$0.560241 per \$100 valuation, the average homestead owner would pay approximately \$26.03 more annually compared to the no-new-revenue tax rate. This increase supports continued city services and equipment investments.
